MANUSCRIPT SUBMISSION GUIDELINES

JAI AER is a peer reviewed journal. After preliminary scrutiny, manuscripts of AIAER members, prepared and submitted as per JAI AER guidelines are sent for peer review and feedbacks, if any received from reviewers are intimated to the authors.

Manuscripts are to be typed on one side of the paper double-spaced with margins 1 inch (2.5 cm) all around, left justified only.

For anonymity in the reviewing process, paper title, name(s) of the author(s) and address for correspondence should be placed on a separate sheet.

The first page of the manuscript should include the title only.

An abstract of 150 words should accompany each manuscript.

New paragraphs should be indicated by clear indentation.

Quoted passages longer than 3 lines should be indented throughout.

There should not be endnotes and footnotes.

Single foreign words and phrases should be italicized.

Tables and Figures should be avoided and if included, must not be included as part of the text.

These have to be provided in separate sheets and the approximate position of tables and figures must be indicated in the manuscript. Tables should be numbered by Roman numerals and Figures by Arabic numerals.

Manuscripts should run between 20 and 50 pages in 11-point type.

Each manuscript must accompany the undertaking of the author(s) that the said manuscript has neither been sent to any other journal or to any other publisher. Authors are also to mention their AIAER membership numbers.

Three copies of the manuscript are to be sent by post to the Associate Editor at the following address:

The soft copy should not have headers and footers, as well as page numbers and should be submitted as Word documents.

Bibliographical references should be arranged alphabetically and should be given at the end of the text in the following format.

In-text references should be mentioned in the in the text as: author, year of publication and page, e.g.,

Single author: (Mishra 2006, p.67);

Two authors: (Mishra & Singh 2009, p. 67)

More than three authors: While citing first time: (Mishra, Naik, Roy & Singh 2009, p.54). In subsequent citation: (Mishra et al. 2009, p.66)

Organisation as an author : According to the All India Association for Educational Research (1987, p.34),... In subsequent citation to use abbreviated form AIAER (1987, p.49)

Two or more works in the same Parentheses

(Mishra 2009, p.67; Singh 2009, p.57)

Two or More Works by the same author in the same year

(Mishra 2009 a, p.55) (Mishra 2009b, p. 43)

Authors with the same last name

(C.A. Mishra 2009, p.44; D.C. Mishra 2006, p.53)

In case of a work by three to five authors, while citing for the first time, mention last names of all authors and in case of subsequent citations in the same article, mention the last name of the first author followed by “et al.”

In case of a work having more than five authors, mention the last name of the first author followed by “et al.”

the signal phrase or in parentheses more than three authors, while mentioning for the first time give, all surnames and in case of subsequent mention of the same study , use first author’s surname followed by et al.
